Deaar Sirs,

I. Introductory Notes

Following your order, we completed the verification of the value of the assets and liabilities of the New Automobiles & Spare Parts Import & Trading Segment of the Joint-Stock Company (Societe Anonyme) under the name “AUTOHELLAS Tourist and Trading S.A.” (hereinafter, the **"Company"** or **"Contributor"**), based on the provisions of Law 1297/1972, in order for this segment to be contributed (transferred) into a new Company, which to be established first.

The aforementioned verification of the value of the Company's assets was carried out on the basis of Article 17(3) Law 4548/2018, which stipulates that *“For the verification of the value of the contributions in kind at the establishment of the company, and any increase in its capital, a valuation report shall be drawn up by two certified public accountants-auditors or an auditing company or, where applicable, by two independent certified valuers. The auditors or certified valuers may hire special valuers, whether domestic or foreign, for the valuation of assets that require specialized knowledge or international experience”*.

I. Introductory Notes - Next

Regarding the content of the valuation report, the provisions of paragraphs 5 and 6 of Article 17 of Law 4548/2018 were applied, stipulating that *"5. The valuation report must contain the description of each contribution in kind, indicate the valuation methods applied and give an opinion on the value of each contribution. If the valuation results in a range of values, the report must indicate a final value.*

6. More specifically, the valuation of fixed assets must take into account their actual and legal condition and any burden, as well as: (a) in the case of real estate property, its value and acquisition titles, the commerciality of the area, the prospects for growth, the actual current prices, the building permit and the respective technical report by an engineer; (b) in the case of machinery, transport means and furniture, the date and value of their acquisition, the rate of their utilisation, maintenance and marketability, their potential technological obsolescence and the current prices for identical or similar assets."

For the spin-off and contribution of the segment, we were notified of: (a) The decision of the meeting of the Board of Directors of the Joint-Stock Company (Societe Anonyme) under the name "AUTOHELLAS Tourist and Trading S.A." of March 6, 2019; (b) The segment's Balance Sheet dated 31.12.2018.

II. The Company

A. History of the Company

The Company was established by Deed No. 9575/1962 of the Athens Notary, Christos Evangelos Koutsimpos, published in the Government Gazette Issue No. 355/20.06.1962. The Company bears the former registration number of joint-stock companies 851/06/B/ 86/43 and the General Commercial Registry (GCR) No. 250501000. The following information is available from the latest codified Statute¹ of the abovementioned Company:

Name

According to Article 1 of its Statute - as amended and currently in force - the name of the Company is "AUTOHELLAS Tourist and Trading S.A."

Duration

The duration of the Company was initially set at thirty (30) years and commences from the registration of the administrative decision for the authorization of the establishment of this Company and the approval of its Statute by the competent supervisory authority in the Joint-Stock Companies Registry.

Already, by decision of the Regular General Meeting of the Company's Shareholders dated 30.06.1990, the duration of the Company was extended for sixty (60) years, starting from the date of expiry of the initial term and expiring on 20.06.2052.

Headquarters

The headquarters of the Company are located in the Municipality of Kifissia.

II. The Company– Next

A. History of the Company– Next

Purpose

Pursuant to Article 2 of the Statute, the purpose of the Company is:

(a) Rental of, indicatively, cars, trucks of all types and all kinds of vehicles, machinery vehicles, construction machinery, agricultural machinery, electrically powered machines and machinery of all types, tools, mechanical installations, mechanical, electronic and generally, any kind equipment, generators and other related items, prefabricated ISOBOX-type houses, as well as the exercise of any activity related to the maintenance, operation and exploitation or all of the above. To this end, the company may acquire or grant operating licenses, sub-licenses and enter into franchise and sub-franchise agreements.

(b) import, export and marketing of, indicatively, cars, machinery vehicles, construction machinery, agricultural machinery, electrically powered machines and machinery of all types, tools, mechanical installations, mechanical, electronic and generally, any kind equipment, generators, all kinds of spare parts and other related items.

(c) Exercise of any activity related to the maintenance, operation and exploitation of car fleets, property of the company or third parties.

(d) Operation of aircrafts, ships of all types and airports and provision of related services in ports and airports, such as, indicatively, groundhandling services, ship and aircraft catering, cargo handling.

(e) Establishment and operation of hotels, tourist complexes, tourist agencies, hostels, tourist kiosks and, generally, facilities directly or indirectly linked to hotel and tourist activities, including thematic and amusement parks, golf courses, thalassotherapy centers, sports facilities and shopping centers. Establishment, rental, acquisition and operation of tourist ports for yachts (marinas).

(f) Exercise of activity related to the supply and production of energy from renewable sources.

(g) Any work or service provided, relevant, supplementary or ancillary to the above objectives, which facilitates the progress and expansion of the Company's operations.

For the fulfillment of the above objectives, the Company may (a) participate in any enterprise of any corporate type and object; (b) cooperate with any individual or legal entity in any way; (c) establish branches or agencies; (d) represent any domestic or foreign company; and (e) provide loans or guarantees to companies with which it has business relations or are its subsidiaries, subject to the express reservation of Article 23a of Codified Law 2190/1920.

Share Capital

The Company's share capital currently amounts to Euros three million nine hundred and eighty thousand four hundred (€ 3,908,400) and is divided into twelve million two hundred and thirteen thousand seven hundred and fifty (12,213,750) registered shares with a nominal value of € 0.32 each.

The share capital was formed as follows:

The Company's share capital was initially set at Drachmas one million (1,000,000) divided into one thousand (1,000) bearer shares with a nominal value of Drachmas one thousand (1,000) each, paid according to those stipulated in the published Statute (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 355/20.06.1962).

By decision of the Shareholders' General Meeting dated 03.05.1975, the share capital was increased by Drachmas nine million (9,000,000) and five thousand (5,000) bearer shares with a nominal value of Drachmas one thousand (1,000) each and four thousand (4,000) registered shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 1671/02.07.1975).

By decision of the Shareholders' General Meeting dated 06.03.1980, the share capital was increased by Drachmas forty million (40,000,000) through capitalization of an equal claim by a shareholder against the Company and forty thousand (40,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 1469/13.05.1980).

By decision of the Shareholders' General Meeting dated 22.01.1981, the share capital was increased by Drachmas twenty five million (25,000,000) δραχμές and twenty five thousand (25,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 1921/1981).

By decision of the Shareholders' General Meeting dated 30.11.1981, the share capital was increased by Drachmas twenty five million (25,000,000) δραχμές and twenty five thousand (25,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 4127/24.11.1982).

By decision of the Shareholders' General Meeting dated 20.11.1982, the share capital was increased by Drachmas fifty million (50,000,000) through capitalization of the revaluation surplus of the Company's real estate property, pursuant to the application of Law 1249/1982, amounting to Drachmas fourteen million four hundred sixty thousand one hundred fifty (14,460,152) plus Drachmas five hundred thirty nine thousand eight hundred forty eight (539,848) for rounding and by cash payment of Drachmas thirty five million (35,000,000) and fifty thousand (50,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 88/17.01.1983).

By decision of the Shareholders' General Meeting dated 17.11.1984, the share capital was increased by Drachmas fifty million (50,000,000) and fifty thousand (50,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 740/05.04.1985).

By decision of the Shareholders' General Meeting dated 17.12.1985, the share capital was increased by Drachmas seventy million (70,000,000) and seventy thousand (70,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 593/14.03.1986).

By decision of the Shareholders' General Meeting dated 16.02.1989, the share capital was increased by Drachmas three hundred thirty million (330,000,000) (a) through capitalization of the surplus of the Company's real estate property, pursuant to Decision No. E2665/84/22.02.1988 of the Minister of Finance, amounting to Drachmas one hundred sixty million seven hundred sixty seven thousand two hundred thirty two (160,767,232), (b) by cash payment of Drachmas seven million nine hundred eighty two thousand seven hundred sixty eight (7,982,768) for rounding and (c) by cash payment of Drachmas one hundred sixty one million two hundred fifty thousand (161,250,000). The same Meeting decided the issuance of three hundred thirty thousand (330,000) bearer shares with a nominal value of Drachmas one thousand (1,000) (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 3168/10.08.1989).

By decision of the Shareholders' General Meeting dated 27.03.1992, the share capital was increased by Drachmas one hundred million (100,000,000) and one hundred thousand (100,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 3782/23.07.1992).

By decision of the Shareholders' General Meeting dated 23.03.1993, the share capital was increased by Drachmas three hundred million (300,000,000) (a) through capitalization of the surplus of the Company's real estate property, pursuant to the application of Law 2065/1992, amounting to Drachmas thirteen million eight hundred thousand (13,800,000) and (b) by cash payment of Drachmas two hundred eighty six million two hundred thousand (286,200,000) and three hundred thousand (300,000) bearer shares with a nominal value of Drachmas one thousand (1,000) were issued (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 1444/03.05.1993).

By decision of the Shareholders' General Meeting dated 23.04.1998, the share capital was increased by Drachmas one billion seven hundred million (1,700,000,000) (a) the share capital was increased by Drachmas three hundred million (300,000,000) (a) through capitalization of the surplus of the Company's real estate property, pursuant to the application of Law 2065/1992, amounting to Drachmas one hundred and one million five hundred six thousand two hundred six (101,506,206), (b) through capitalization of Drachmas three hundred forty one million one hundred ninety nine thousand five hundred forty five (341,199,545), recorded in the Company's books as profits carried forward and (c) by cash payment of Drachmas one billion two hundred fifty seven million two hundred ninety four thousand two hundred forty nine (1,257,294,249). The same Meeting decided the issuance of one million seven hundred thousand (1,700,000) bearer shares with a nominal value of Drachmas one thousand (1,000) (Government Gazette, Joint-Stock and Limited Liability Companies Issue No. 2512/18.05.1998).

By decision of the Shareholders' General Meeting dated 07.12.1998, two million six hundred ninety six thousand (2,696,000) bearer shares were converted into registered.

By decision of the Extraordinary Shareholders' General Meeting dated 14.12.1998 in conjunction with the decision of the Regular Shareholders' General Meeting dated 30.04.1999 (a) the Company's shares were listed on the main market of the Athens Stock Exchange, (b) the share capital was increased by Drachmas nine hundred million (900,000,000) through the issuance of four million five hundred thousand (4,500,000) registered shares with a nominal value of Drachmas two hundred (200) each. Equity premium from the issuance of these four million five hundred thousand (4,500,000) new common registered shares, shall be credited into the "Share premium" account. Of these four million five hundred thousand (4,500,000) new common registered shares, two hundred fourteen thousand (214,000) shall be allocated privately to the Company's staff and associates and the remaining four million two hundred eighty six thousand (4,286,000) common registered shares shall be available through a public subscription to the broader investing public and (c) old shareholders waived their pre-emptive right to that share capital increase.

By decision of the Regular Shareholders' General Meeting dated 28.06.2002, the Company's share capital was mandatory increased by Euros fifty five thousand sixty nine and seventy five cents (55,069.70) through capitalization of part of the equity premium due to increase in the nominal value of each share from € 0.5869 to € 0.59. The same Meeting decided the nominal value of each share to be converted from Drachmas into Euros and consequently, the Company's share capital to be converted into Euros. Thus, the Company's share capital amounts to Euros ten million six hundred twenty thousand (10,620,000), divided into 18 million (18,000,000) common registered shares with a nominal value of € 0.59 each.

By decision of the Regular Shareholders' General Meeting dated 28.06.2002, the Company's share capital was further increased by Euros seven hundred twenty thousand (720,000) through capitalization of (a) the reserve from the revaluation of the remaining assets, amounting to € 684,865.63 and (b) the equity

premium, amounting to € 35,134.37 and simultaneous increase in the nominal value of each share from € 0.59 to € 0.63.

Thus, the Company's paid-up share capital amounts to Euros eleven million three hundred forty thousand (11,340,000), divided into 18 million (18,000,000) common registered shares with a nominal value of € 0.63 each.

By decision of the Regular Shareholders' General Meeting dated 27.05.2004, the nominal share value was reduced (Split) from €0.63 to € 0.315 with corresponding increase of the number of shares from 18 million (18,000,000) to thirty six million (36,000,000), and for the purpose of rounding, the Company's share capital was simultaneously increased through capitalization of share premium reserves, amounting to Euros one hundred eighty thousand (180,000), and increase in the nominal value of each Company share from € 0.315 to € 0.32.

Thus, the Company's paid-up share capital amounts to Euros eleven million five hundred twenty thousand (€ 11,520,000), divided into thirty six million (36,000,000) common registered shares with a nominal value of € 0.32 each.

By decision of the Regular Shareholders' General Meeting dated 22.05.2003, a share prescription scheme to company's executives in the form of pre-emptive right was adopted, according to Article 13(9) of Codified Law 2190/1920. In execution of this decision, on 20.12.2005 the Board of Directors decided unanimously (a) the share capital of the company to be increased by the amount of € 38,400 that corresponds to the nominal value of the new shares and a share premium reserve to be formed with the remaining amount of € 201,600 and (b) the issuance of 120,000 common registered shares with a nominal value of € 0.32 each and a subscription price of € 2.00 which shall be offered to the beneficiaries.

Thus, the Company's paid-up share capital amounts to Euros eleven million five hundred fifty eight thousand four hundred (11,558,400), divided into thirty six million one hundred twenty thousand (36,120,000) common registered shares with a nominal value of € 0.32 each.

By decision of the company's Board of Directors dated 20.12.2007 and in execution of the decision of the Regular Shareholders' General Meeting dated 22.05.2003, adopting a share prescription scheme to company's executives in the form of pre-emptive right, according to Article 13(9) of Codified Law 2190/1920, it was unanimously decided (a) the share capital of the company to be increased by the amount of € 76,800 that corresponds to the nominal value of the new shares and a share premium reserve to be formed with the remaining amount of € 403,200 and (b) the issuance of 240,000 common registered shares with a nominal value of € 0.32 each and a subscription price of € 2.00 which shall be offered to the beneficiaries.

Thus, the Company's paid-up share capital amounts to Euros eleven million six hundred thirty five thousand two hundred (11,635,200), divided into thirty six million three hundred sixty thousand (36,360,000) common registered shares with a nominal value of € 0.32 each.

By decision of the Extraordinary Shareholders' General Meeting dated 15.02.2008, the nominal share value was increased by € 1.30 and the share capital was increased by € 47,268,000 through capitalization of (a) € 31,626,186.83 from the "Share premium" reserve and (b) € 15,641,813.17 from the "Profits, carried forward" account. By the same decision of the Extraordinary General Meeting, the nominal share value was reduced by € 1.30 and the share capital was reduced by € 47,268,000, for the actual distribution of the reduction product to the Company's shareholders.

Thus, the Company's paid-up share capital amounts to Euros eleven million six hundred thirty five thousand two hundred (11,635,200), divided into thirty six million three hundred sixty thousand (36,360,000) common registered shares with a nominal value of € 0.32 each.

By decision of the Regular Shareholders' General Meeting dated 28.06.2013:

i. the nominal share value was increased through Reverse Split from € 0.32 to € 0.96 and 12,120,000 new shares were issued in replacement of the 36,360,000 old shares. Thus, the Company's paid-up share capital amounted to € 11,635,200, divided into 12,120,000 common registered shares with a nominal value of € 0.96 each.

ii. the share capital was reduced by € 7,756,800 through reduction of the nominal share value from € 0.96 to € 0.32 and reimbursement of cash to the shareholders.

As a result of the reduction above, the Company's share capital amounted to € 3,878,400, divided into 12,120,000 common registered voting shares with a nominal value of € 0.32 each.

By decision of the Extraordinary Shareholders' General Meeting dated 31.10.2014, the merger by absorption of the company under the name "VACAR CRAFT AND TRADING S.A." by the Company was adopted, as well as the Company's share capital to be increased by € 12,000, as a result of that merger, by the issuance of 37,500 new common registered voting shares with a nominal value of € 0.32 each.

As a result of the abovementioned increase due to merger, the Company's share capital currently amounts to € 3,890,400, divided into 12,157,500 common registered voting shares with a nominal value of € 0.32 each.

By decision of the Extraordinary Shareholders' General Meeting dated 15.09.2015, the merger by absorption of the companies under the names "VELMAR HELLENIC AUTOMOBILES AND AGENCIES - TRADING AND INDUSTRIAL S.A." and "TECHNOCAR CRAFT AND TRADING S.A." was adopted, as well as the Company's share capital to be increased by € 18,000, as a result of that merger, by the issuance of 56,250 new common registered voting shares with a nominal value of € 0.32 each.

B. Information, on which the verification of the value of corporate contributions in kind was based

During the execution of our tasks, we chose the method of valuation of Assets and Liabilities at fair values, which for most assets and liabilities are identical to the historical cost, mainly due to the company's purpose and the accounting principles and methods of assets valuation followed by the company.

Under this method, the values of the company's main assets are estimated and adjusted accordingly. Therefore, this method requires auditing and, possibly, adjusting the book value (in relation to their current value) of the following indicative asset classes:

1. Tangible assets, such as equipment, machinery, etc.
2. Intangible assets, such as patents, registered trademarks, clientele, workforce, good reputation, etc.
3. Value of stocks
4. Current/collectable value of receivables, etc.

According to this method, the value of each of the above assets is adjusted if there is evidence that their book value does not correspond to the current market value.

It is noted that according to the International Financial Reporting Standards, the main adjustments from those above (e.g. 1,3,4) may be integrated in the audited financial statements, on which the Certified Public Accountants - Auditors should not have made comments.

This choice was made because all the required adjustments have been made in the financial statements so that the book value of the majority of the assets and liabilities corresponds to their current market values.

Furthermore, in order to confirm the net worth of the company's segment, we proceeded with the following actions:

- (a) We have reviewed the audited financial statements of the Company as at 31.12.2017 and the published financial statements of the Company as at 31.12.2018.
- (b) We have collected information on the Company's financial figures and activity on the basis of its accounting books. It is noted that the Company keeps its books primarily under the International Financial Reporting Standards (IFRS).

Information on which the estimate was based

The basis of the work, which was carried out to estimate the value of the assets and liabilities of the Company's segment to be spin-off and contributed, was as follows:

(a) Segment's Balance Sheet as at 31.12.2018

For the purpose of the spin-off and contribution of the segment, the Board of Directors decided to use the audited published financial statements of 31.12.2018 and the inventory for all the assets and liabilities that was prepared accordingly. Based on this inventory, the Balance Sheet of the segment being spin-off and contributed as at 31.12.2018 was drawn up, showing the overall assets and liabilities of the segment being spin-off and contributed.

(b) Various information

Information on the Company's economic aggregates and activity is collected from its accounting books. it is noted that the Company primarily keeps its accounting books under the International Financial Reporting Standards (IFRS).

C. Segment's Financial Position (Balance Sheet) as at 31.12.2018

The account above refers to fixed assets (signboards – display signs, bearing the SEAT logo), installed at car dealers, i.e. customers of the segment, with acquisition cost € 122,640.07 and accumulated depreciation € 2,389.03 , reconciling with company's fixed assets registry.(see Appendix B)

The review of the Fixed Assets Registry concluded that the Company performs the annual depreciation required, based on the useful lifetime of these assets, estimated at 25 years.

The Committee's estimate equals the residual value, as evidenced by the Company's Assets Registry.

Brand Name

In order to value the fair value of the "Technocar" brand name on 31.12.2018, the Relief from Royalty Method was used. According to this method, an intangible asset can be valued on the basis of the present value of the hypothetical payments for royalties (user rights) being saved due to the ownership of the asset compared to its non-ownership and lease by a third company.

Valuation of Intangible Assets of Technocar Sector of Autohellas S.A. as at 31.12.2018

Dear Sirs,

Pursuant to your instructions dated 14 March 2018, Deloitte Business Solutions S.A. (Greece) (hereafter referred to also as "Deloitte") has provided valuation services to QAS Certified Public Accountants Ltd. (hereafter referred to also as the "Client"), with regards to the estimation of the fair market value of intangible assets of the sector of import and trade of SEAT cars and SEAT and SAAB spare parts in Greece (hereinafter referred to also as the "Sector" or "Technocar") of Autohellas S.A., in the context of a carve-out of the Sector, with valuation reference date 31.12.2018, for the purposes of the preparation of financial statements, as at 31.12.2018, of the new company to which the Sector shall be contributed, in accordance with IFRS.

The intangible assets that have been recognised and valued comprise the Customer Relationships of Technocar with SEAT car and SEAT and SAAB spare parts dealers and the brand name "Technocar".

Customer Relationships

- For the estimation of the fair market value of the Customer Relationships of the Sector as at 31.12.2018, we applied the Multi-Period Excess Earnings Method. This method estimates the value of an intangible asset based on the future incremental earnings that this asset is projected to generate. These incremental earnings are calculated as the difference between the total operating income after taxes and the required cost of invested capital (capital charges) for all the other assets that contribute in the production of the relevant products or services. The value of the intangible asset is estimated based on the discounted future incremental earnings generated during the useful life of the intangible asset.
- This method is based on a) the determination of the operating income that is attributed to the subject intangible asset and b) the determination of the relevant contributory asset charges.
- Thus, for the application of the Multi-Period Excess Earnings Method, all other assets that contribute to the production of the relevant products or services, need to be identified and valued in advance of the valuation of the subject intangible asset, so that the aforementioned capital charges for their usage can be determined.

Brand Name

- For the valuation of the fair market value of the brand name «Technocar» as at 31.12.2018, we applied the Relief from Royalty Method. This method estimates the value of an intangible asset based on the present value of the hypothetical royalty payments for usage rights that are saved due to the ownership of the subject intangible asset in comparison with the hypothetical scenario of not owning and renting such intangible asset from a third party.

Synopsis of Results

- The results of the valuation of the intangible assets of the Sector as at 31.12.2018 are presented in the table below.
